### **Required Documentation**

(Check all that apply)

- Current Pictures of existing conditions identifying the areas to be modified (*required*)
- Professionally prepared plans, drawn to scale (*structure & property modifications only*)
- Property Site plan identifying property lines & easements (*structure & property modifications only*)
- Building Materials List – an itemized material list (*required*)
- Exterior Paint/Stain Colors – sample swatches and/or color schemes must be submitted identifying the color of siding, trim, accents, doors, etc. (*required*)
- Exterior Lighting Specifications – Summit County Code requires dark skies compliant fixtures (*required*)
- Summit County Building Permit (*as needed*)
- HOA board approval (if applicable)
- Duplex/Triplex/Multi-family units are required to perform the work simultaneously

The review and approval process may take up to 30 days after submission. Submit applications by noon the 2<sup>nd</sup> Thursday of each month to be included at the monthly Board Meeting.
